Forms Competition

Refer to the 1996 Wushu Competition Rules for the criteria of standard and scoring method. Requirements for the difficult moves (nandu) will not apply.

Time requirements

Tai Chi –group set 3-4 minutes (the chief judge will give notice when 3 minutes pass) .

Traditional routine – 30 seconds or more , on the training of not less than 40 seconds.

Contemporary routines – must be 1 minute or longer (free-style routine for advanced contemporary routine must be 1.20 minutes or longer) . Traditional routine – 40 seconds or longer

Taking place

- 1 `primary group, as well as the intermediate group, in accordance with the provisions of 123, such as the taking of prizes.
- 2 `high-level group were taking men and women in the top six. The number of individual entries for less than 6 man-hours, reduced to take place 1.
